# **Position Summary**

The ideal candidate will have at least two (2) years of experience with strong skills in fundraising strategy, development operations, communications, donor engagement, and stakeholder management. Applicable sales or account management experience will be considered. The candidate will have excellent communication and writing skills, impeccable attention to detail, and the ability to prioritize multiple tasks and meet deadlines. They must also have a strong affinity for Combined Arms' mission and a growth mindset. This role will report directly to the Chief Development Officer and will be located in our Houston, TX office. Arrangements for alternate locations or remote work may be made for the right candidate.

# **Key Responsibilities & Duties**

- Help secure funding across all revenue sources, including foundations, corporations, and individuals:
- Support prospect research on individuals, corporations, foundations, and organizations that are plausible fits for CAX as potential donors;
- Support the development of fundraising proposals and reports. This may include drafting narratives; compiling project data, financial information, and budgets; liaising with CAX's finance team on budget approvals; and tracking project progress;

- Oversee donation processing and prepare acknowledgement letters and other correspondence;
- Database administration including the creation of monthly fundraising reports and dashboards and maintenance of donor records;
- As a front-line fundraiser, the coordinator will respond to community requests for support in their 3rd party fundraising efforts. This may include leading tours of CAX's Transition Center, attending check presentations, and providing event-related assistance to interested donors.
- Represent Combined Arms at events as required;
- Other duties as assigned

#### Qualifications, Skills, and Attributes

- Bachelor's Degree or equivalent work experience required;
- Two (2) or more years' experience in a professional office environment, nonprofit, event/hospitality management, previous fundraising/development experience preferred;
- Prior experience providing administrative, logistical, or customer support for an organization (with adequate technical proficiency both online and in-person)
- Detail-oriented. The development coordinator must be committed to excellence, even in the small things. They should seek to detect errors in their own work and obsessively pursue improvement in everything they do;
- Self-starter. The development coordinator should be ready and willing to operate
  independently without detailed instructions. They should be able to prioritize their work
  on their own based on their given responsibilities and the intent of the Chief
  Development Officer;
- Superb written communication skills. This is crucial for this position. The development coordinator will be expected to produce high quality written material on a daily basis, including but not limited to:
  - Formal email correspondence;
  - Grant applications;
  - Marketing copy;
  - Event invitations;
- Analytical. Research is a key task in identifying and pursuing fundraising opportunities.
   The development coordinator should be prepared to conduct detailed research on:
  - Funding Sources
    - Grants and grant-giving institutions;
    - High net-worth individuals;
    - Corporations and corporate social responsibility programs;
  - Market
    - Veteran trends and issues:
    - Major partnerships and coalitions in the space;
    - Relevant government and political activity:
    - Competitors;

    - Existing donor data;
    - Programmatic activity and historical data;
- Persuasive. The development coordinator will be expected to create, manage and build relationships. They should be able to effectively represent Combined Arms in person, in written correspondence, and in public.
